Sub: 29th Annual General Meeting (AGM) of Gujarat Investa Limited held on Thursday, the 30th September, 2021 at 12:30 P.M. at 252, New cloth market, O/s Raipur Gate, Ahmedabad-380002.

I, Umesh Ved, Proprietor of M/s. Umesh Ved & Associates, Company Secretaries, Ahmedabad, was appointed as Scrutinizer for the purpose of scrutinizing the Remote E-Voting process and voting at the 29th Annual General Meeting ("AGM") pursuant to Section 108 & 109 of the Companies Act, 2013 read with rule 20 of Companies (Management and Administration) Rules, 2014, as amended on the resolutions contained in the Notice to the 29th AGM of the Members of "Gujarat Investa Limited" (the Company) held on Thursday, the 30th September, 2021 at 12:30 P.M. at 252, New cloth market, O/s Raipur Gate, Ahmedabad-380002.

My responsibility as scrutinizer for the voting process is restricted to preparing a Scrutinizer's Report of the vote casted "in favour" or "against" the resolution(s) based on the reports generated from the Remote e-voting system provided by the Central Depository Services (India) Limited (the Agency/service provider) and the Polling at the AGM.

I submit my report as under:

- i. After the time fixed for closing of the poll by the Chairman, one ballot box kept for polling was locked in my presence with due identification marks placed by me.
- ii. The locked ballot box was subsequently opened in my presence and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Registrar and Transfer Agents of the Company and the authorizations / proxies lodged with the Company.
- iii. The shareholders of the Company holding shares as on the "cut-off" date 23rd September, 2021, were entitled to vote on the proposed resolutions as set out in item nos. 1 to 4 in the Notice of the AGM of Gujarat Investa Limited.

- iv. The facility provided for Remote E-Voting commenced from 9.00 A.M. on Monday, the 27^h September, 2021 and ended on 5.00 P.M. on Wednesday, the 29th September, 2021. The Remote E –voting facility was blocked thereafter.
- v. At the venue of the AGM the facility to cast vote by poll was provided to facilitate those members present at the AGM who could not participate through Remote E-voting, to record their votes. After counting of the votes conducted at the venue of the AGM through Ballot, the votes casted through Remote E-voting were unblocked by me in the presence of two witnesses, namely, Mr. Abijit Roy and Mr. Sachin Shah who are not in employment of the company. They have signed below in confirmation of the votes being unblocked in their presence.



- vi. The voting done through Remote E-voting and Polling at the meeting were reconciled with the records maintained by the RTA and the authorizations / proxies lodged with the Company.
